## **SECTION 5: Firefighting Measures**

#### Suitable fire extinguishing media:

## **SECTION 6: Accidental Release Measures**

#### Personal precautions:

Put on appropriate personal protective equipment (see section 8)

#### Environmental precautions and clean-up methods:

Stop all leaks. Isolate hazard area. Keep unnecessary and unprotected personnel from entering. Eliminate all ignition sources. Disperse vapors with water spray.
