## SECTION 4: First Aid Measures

### EMERGENCY OVERVIEW

and flash back, causing fire or explosion. Bursting aerosol containers may be propelled from a fire at high speed. Runoff to sewer may create fire or explosion hazard.

### Specific fire-fighting methods:

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Move containers from fire area if this can be done without risk. Use water spray to keep fire-exposed containers cool.

### Special protective equipment for fire fighters:

## SECTION 6: Accidental Release Measures

Transfer contaminated absorbent, soil and other materials to containers for disposal.
