EMERGENCY OVERVIEW

DANGER. Extremely flammable. Contents under pressure. Harmful or fatal if swallowed. Aspiration hazard if swallowed. Vapor harmful. Keep away from heat and flame. Can cause nervous system depression.

EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. If eye irritation persists: Get medical attention.

SECTION 5: Firefighting Measures

Suitable fire extinguishing media:
